- HB 1043 FANNIN FINANCIAL INSTITUTIONS** Requires a financial institution to file a certificate of occupancy with the local conveyance records office
- HB 1067 EDWARDS MORTGAGES** Provides relative to the cancellation of certain mortgages and vendor's privileges
- HB 1159 ST. GERMAIN FIRE PROTECT/FIRE MARSHAL** Provides for emergency access to elevators
- HB 1162 WOOTON ATTORNEY GENERAL** Authorizes the attorney general to investigate commercial and trade practices of motor carriers transporting household goods
