SB 338	NEVERS	SCHOOLS Provides for group health insurance coverage for certain employees of the Recovery School District and Type 5 charter schools. (gov sig)
HB 178	GISCLAIR	HEALTH Requires certain students to be vaccinated against meningococcal disease
HB 321	TRAHAN	SCHOOLS/CHARTER Provides relative to the limitation on the number of charter school proposals allowed
HB 349	TRAHAN	SCHOOLS/CHARTER Provides relative to the charter school renewal period

HB 574	SMITH, GARY	SCHOOLS Prohibits interactions between students and school employees in public elementary and secondary schools except in accordance with specified guidelines and limitations adopted by BESE
HB 657	TRAHAN	SCHOOLS/EMPLOYEES Prohibits requiring school employees to complete paperwork if the information provided for in such paperwork is available from another source
HB 741	GUILLORY,	SCHOOLS/EMPLOYEES Provides extended sick leave benefits to certain public school employees not required to hold a teaching certificate
HB 754	DIXON	STUDENT/DISCIPLINE Requires public school governing authorities to take certain actions relative to student awareness and understanding of school discipline rules and requirements
HB 1053	HARRISON	EDUCATION/SPECIAL Provides for comprehensive revision of the educational opportunities for children with exceptionalities provisions
HB 1105	TRAHAN	SCHOOLS/CHARTER Provides relative to charter school funding
HB 1256	DOWNES	SCHOOLS/BOARDS Provides relative to training and instruction for public school board members and requires that a certain number of hours focus on certain topics
