<b>SB 197</b>	<b>HEBERT</b>	<b>HAZARDOUS WASTE</b> Provides that the time limitation for instituting prosecution for criminal violations of the Hazardous Waste Control Law begins to run from discovery of the violation. (8/15/08)
<b>SB 321</b>	<b>HEBERT</b>	<b>ENVIRONMENT QUALITY DEPT</b> Authorizes DEQ to accept credit cards for payment of obligations owed to the state through use of a third-party processor to collect a convenience fee to adequately cover transaction fees. (gov sig)
<b>SB 326</b>	<b>HEBERT</b>	<b>ENVIRONMENT QUALITY DEPT</b> Provides DEQ with authority to license sewage haulers. (7/1/09)

**SB 384 HEBERT**

**ENVIRONMENTAL CONTROL** Authorizes DEQ to require facilities to keep records showing potential emissions are below Act 918 thresholds and to define potential emissions. (8/15/08)
