

Current-Year Cost Drivers

- ▶ Bayou Health enrollment growth: in the last year family and children have increased by 76,130
 - 9.6% increase in this eligibility group
- ▶ Medicare Part B premiums are scheduled to increase from \$104.90 to \$159.30 on January 1, 2016
 - 52% increase in these premiums
- ▶ Utilization increases
 - Pharmacy program – average acquisition cost (ACC)
- ▶ Annualization of home- and community-based waivers
