<b>HB 140</b>	<b>KLECKLEY</b>	<b>INSURANCE/AUTOMOBILE</b> Removes reference to repealed statute in uninsured motorist law
<b>HB 141</b>	<b>KLECKLEY</b>	<b>INSURANCE/HOMEOWNERS</b> Corrects the statutory reference to homeowner's insurance
<b>HB 222</b>	<b>KLECKLEY</b>	<b>INSURANCE/POLICIES</b> Requires filing with and approval of property residual value insurance policies by the commissioner of insurance and authorizes fees
<b>HB 223</b>	<b>KLECKLEY</b>	<b>INSURANCE COMMISSIONER</b> Requires certain insurers, health maintenance organizations, managing general agents, and third-party administrators to maintain written catastrophe plans
<b>HB 237</b>	<b>KLECKLEY</b>	<b>INSURANCE DEPARTMENT</b> Requires commissioner of insurance review and approval of vehicle mechanical breakdown insurance policies
<b>HB 512</b>	<b>PETERSON</b>	<b>INSURANCE/HEALTH</b> Requires health insurance coverage for mammography examinations as provided by the American Cancer Society

<b>HB 606 LOPINTO</b>	<b>INSURANCE/AUTOMOBILE</b>	Provides for discounts on automobile insurance with vehicles that have certain features
<b>HB 1113 MONICA</b>	<b>INSURERS</b>	Provides relative to the statutory deposit requirements of insurers
<b>HB 1130 ROBIDEAUX</b>	<b>INSURERS/AGENTS</b>	Provides relative to ownership of client files by insurers
<b>HB 1332 PETERSON</b>	<b>INSURERS/AGENTS</b>	Requires the commissioner of insurance to publish a report regarding life insurance agent examinations
<b>HB 1360 MILLS</b>	<b>INSURANCE/LIFE</b>	Provides relative to a life insurance policy or annuity issued to fund a pre-need funeral contract
