  - HB 191    KLECKLEY                                      INSURANCE/HEALTH** Limits retroactive denial and recoupment of health insurance claims
  - HB 224    KLECKLEY                                      INSURANCE COMMISSIONER** Authorizes the commissioner of insurance to assess health maintenance organizations a financial regulation fee
  - HB 369    KLECKLEY                                      INSURANCE** Provides for the state's entry into the Interstate Insurance Product Regulation Compact
  - HB 385    KLECKLEY                                      INSURERS** Provides for ratemaking by La. Citizens Property Insurance Corporation
  - HB 437    KLECKLEY                                      INSURANCE/AUTOMOBILE** Provides relative to deductibles

- HB 512 PETERSON**                      **INSURANCE/HEALTH** Requires health insurance coverage for mammography examinations as provided by the American Cancer Society
- HB 516 CORTEZ**                        **INSURANCE/HEALTH** Provides relative to coverage of rehabilitative services, physical therapy, occupational therapy, and speech and language pathology therapy
- HB 925 CORTEZ**                        **INSURANCE/HEALTH** Provides benefits for certain services performed by licensed marriage and family therapists
- HB 1290 LEBAS**                        **INSURANCE/HEALTH** Requires remittance advice on each pharmacy claim
- HB 1312 PONTI**                        **INSURANCE/AUTOMOBILE** Increases the minimum limits for compulsory motor vehicle liability insurance
