- SB 241 CRAVINS, JR.** **HEALTH/ACC INSURANCE** Provides relative to insurance coverage for rehabilitative physical therapy. (gov sig)
- SB 284 CRAVINS, JR.** **GROUP BENEFITS PROGRAM** Defines "employee" for purposes of the group benefits program to include certain retired members of the classified fire and police civil service. (gov sig)
- SB 60 SHEPHERD** **GROUP INSURANCE** Provides for eligibility of New Orleans school employees retired prior to Jan. 31, 2006, to participate, as a group, in insurance sponsored by the office of group benefits. (gov sig)
- SB 300 ERDEY** **HEALTH/ACC INSURANCE** Provides relative to the Louisiana Health Plan. (8/15/08)
- SB 368 GAUTREAUX, N.** **LIFE INSURANCE** Provides relative to a life insurance policy or annuity which is used to fund a preneed funeral contract. (8/15/08)
- SB 380 MARTINY** **HEALTH/ACC INSURANCE** Provides for the regulation of viatical settlements. (gov. sig.)
- SB 432 LAFLEUR** **INSURANCE CLAIMS** Clarifies application of certain warranties and conditions involving life and health and accident policies. (8/15/08)

- SB 670 LAFLEUR INSURERS** Provides for licensing and continuing education requirements for insurance producers. (8/15/08)
- SB 695 LAFLEUR INSURANCE DEPARTMENT** Provides for filing certain financial reports. (8/15/08)
- SB 464 MURRAY HEALTH/ACC INSURANCE** Provides relative to health care arrangements provided to a health care consumer. (8/15/08)
- SB 502 CROWE GROUP BENEFITS PROGRAM** Provides an exception for Office of Group Benefits programs relative to an employer-provided health plan. (8/15/08)
