MALPRACTICE Provides with respect to qualifications of medical expert witnesses in medical malpractice actions against physicians. (gov sig)

SB 117 AMEDEE

COURTS Provides for the collection and deposit of bench warrant fees and probation fees in the Parish Court for the parish of Ascension. (gov sig)

SB 161	JACKSON, L.	CHILDREN Provides relative to income assignment orders. (8/15/08)
SB 179	QUINN	FAMILY LAW Provides relative to reserving fruits of property as separate property. (8/15/08)
SB 186	MARIONNEAUX	PRESCRIPTION Extends the one year prescription for civil actions generally to two years. (8/15/08)
SB 211	MARIONNEAUX	CIVIL PROCEDURE Increase the monetary amount in controversy necessary to request a jury trial. (8/15/08)
SB 213	MARIONNEAUX	CIVIL PROCEDURE Constitutional amendment to provide for the appellate jurisdiction of a court of appeal and to provide that appellate review extends only to questions of law. (2/3-CA13s1(A))
SB 260	JACKSON, L.	CHILDREN Provides relative to acknowledgments of judgments and paternity.
SB 265	QUINN	CHILDREN Provides relative to the emancipation of minors. (1/1/09)
SB 301	CHAISSON	LIABILITY Provides immunity for certain medical personnel during evacuation or treatment of patients. (gov sig)
SB 330	CHAISSON	LIABILITY Provides relative to limitation of liability for medical services during a declared state of emergency. (gov sig)
SB 416	MURRAY	COMMERCIAL REGULATIONS Enacts the Uniform Unincorporated Association Act. (08/15/08)
SB 427	WALSWORTH	CEMETERIES Requires property used for cemetery purposes to be dedicated as such through recording an instrument with the clerk of court of the parish in which the cemetery is located and with the Louisiana Cemetery Board. (gov sig)
SB 579	MURRAY	CLERKS OF COURT Provides relative to the 41 st Judicial District Clerk of Court. (See Act)

ANIMALS Requires impoundment of dogs with no collar identifying the owner or other form of identification. (8/15/08)
