**LIABILITY** Provides relative to limitation of liability for medical services during a declared state of emergency. (gov sig)

**SB 416 MURRAY**

**COMMERCIAL REGULATIONS** Enacts the Uniform Unincorporated Association Act. (08/15/08)

**SB 613 MURRAY**

**COURTS** Provides relative to the district courts in the parish of Orleans. (8/15/08)

- SB 625 MURRAY COURTS** Postpones the consolidation of the district courts in Orleans Parish until January 1, 2010. (gov sig)
- SB 636 MURRAY ADMINISTRATIVE PROCEDURE** Provides for appeals from decisions of the Office of Community Development on Road Home claims. (gov sig)
- SB 679 KOSTELKA DISCRIMINATION** Provides that prescription is not suspended or interrupted in certain instances in cases of employment discrimination. (8/15/08)
- SB 716 MARTINY JUVENILE JUSTICE** Provides for the confidentiality of juvenile records. (8/15/08)
- SB 781 JACKSON, L. CHILDREN** Provides relative to multi-disciplinary interaction in cases of child abuse or neglect. (gov sig)
