SB 46 **QUINN**

COURTS Requires the Judicial Council and the Louisiana State Law Institute to study the feasibility of creating family courts or domestic relations sections in certain judicial districts. (8/15/08)

SB 93 **QUINN**

PRIVILEGES/LIENS Provides for the notice and place of filing of a federal lien on certain vessels. (8/15/08)

- SB 138 QUINN PRIVILEGES/LIENS** Provides for the cancellation of mortgages by affidavit of lost note. (gov sig)
- SB 173 DUPLESSIS NOTARIES** Exempts the courses of notary study from the law requiring the courses to be taught only by registered proprietary schools. (gov sig)
- SB 285 DUPLESSIS NOTARIES** Provides that the application process to become a notary public shall be administered by the office of the secretary of state and provides procedures. (8/15/08)
- SB 346 GAUTREAUX, N. CLERKS OF COURT** Provides that the Friday of the Cattle Festival shall be a legal holiday for the purpose of authorizing the clerk of court of the Fifteenth Judicial District Court and the clerk of court of the City Court of Abbeville to close their offices on that day. (8/15/08)
- SB 353 GAUTREAUX, N. LIABILITY** Limits liability of volunteer supervisory physicians at certain nonprofit centers. (gov sig)
- SB 543 QUINN LEGIS POWERS/FUNCTIONS** Provides relative to legislative continuances. (8/15/08)
