SB 46 QUINN

COURTS Requires the Judicial Council and the Louisiana State Law Institute to study the feasibility of creating family courts or domestic relations sections in certain judicial districts. (8/15/08)

SB 110 GAUTREAUX, N.

CHILDREN Authorizes the Department of Social Services to intercept and seize casino winnings from

individuals in arrears for child support or owing overpayments to the department. (gov sig)

- SB 186** **MARIONNEAUX** **PRESCRIPTION** Extends the one year prescription for civil actions generally to two years. (8/15/08)
- SB 211** **MARIONNEAUX** **CIVIL PROCEDURE** Increase the monetary amount in controversy necessary to request a jury trial. (8/15/08)
- SB 277** **CROWE** **COURTS** Provides relative to recusal of judges. (gov sig)
- SB 278** **CROWE** **CIVIL PROCEDURE** Allows a party in a civil action to substitute a judge of right under certain circumstances. (gov sig)
- SB 307** **DONAHUE** **CIVIL PROCEDURE** Prohibits recovery for loss of enjoyment of life as a separate element of damages apart from pain and suffering damages and prohibits an instruction to the jury which separates loss of enjoyment of life from pain and suffering. (8/15/08)
- SB 416** **MURRAY** **COMMERCIAL REGULATIONS** Enacts the Uniform Unincorporated Association Act. (08/15/08)
- SB 560** **HEBERT** **EXPROPRIATION** Requires approval of a majority of the elected members of each house of the legislature prior to the expropriation of property.
- SB 652** **MICHOT** **MALPRACTICE** Provides relative to the definitions and general applications of medical malpractice. (8/15/08)
- SB 699** **QUINN** **FAMILY LAW** Provides for voluntary acknowledgments to be signed by both parents and to designate vital records as the central repository for all paternity acknowledgments. (8/15/08)
- SB 700** **QUINN** **INSURERS** Provides for data matching and cooperation with any company licensed to issue insurance policies in the state. (8/15/08)
- SB 766** **MARIONNEAUX** **CIVIL PROCEDURE** Provides relative to the Code of Civil Procedure and consolidation of cases. (gov sig)

HB 84 JONES, ROSALIND CHILDREN/SUPPORT Increases penalties for failure to pay child support under certain conditions

HB 116 JONES, ROSALIND COURTS/DISTRICT Authorizes the 4th JDC to provide that one division of the court shall be a DUI court

HB 130 JONES, ROSALIND COURTS Authorizes the 4th JDC to provide that one division of the court shall be a mental health court

HB 322 JONES, ROSALIND ADOPTION Provides for the adoption of adults
