SB 80	MARTINY	CRIMINAL PROCEDURE Provides for suspension and deferral of misdemeanor and felony sentences and probation in misdemeanor and felony cases. (gov sig)
SB 82	MARTINY	GAMING Enacts provision of law regarding the use of charitable gaming proceeds. (8/15/08)
SB 142	SCALISE	WEAPONS Provides for the confidentiality of certain information submitted to the deputy secretary of public safety of the Department of Public Safety and Corrections to obtain a concealed handgun permit. (8/15/08)

SB 187	MARIONNEAUX	GAMING Authorizes slot machine gaming at an eligible live horse racing facility in Iberville Parish. (8/15/08)
SB 381	MARTINY	GAMING Provides with respect to the licensing of qualified truck stop facilities. (8/15/08)
SB 382	MARTINY	CRIMINAL JUSTICE Provides for continuous revision of the criminal code relative to probation programs and offenses against the person. (gov sig)
SB 398	MARIONNEAUX	FUNDS/FUNDING Provides for distribution of taxes levied by Iberville Parish on net slot machine proceeds and creates the Iberville Parish Excellence Fund and requires deposit of five percent of state net slot machine proceeds in the parish to it. (8/15/08)
SB 467	MARTINY	LAW ENFORCEMENT Provides relative to law enforcement officers and the Louisiana Stadium and Exposition District. (8/15/08)
SB 593	RISER	DISTRICT ATTORNEYS Provides relative to the payment of health insurance premiums for certain district attorneys and by certain judicial districts.(8/15/08)
SB 644	ADLEY	VETERANS AFFAIRS Authorize establishment of Veterans Commemorative Coin Program by the adjutant general for certain veterans. (8/15/08)
SB 688	MURRAY	GAMBLING Provides with respect to the authority of the local governing authority to levy a tax on net slot machine proceeds in Orleans Parish. (8/15/08)
SB 689	MURRAY	GAMING Authorizes the governing authority of Orleans Parish to levy a tax on weekly taxable net slot machine proceeds of a licensed eligible horse racing facility. (8/15/08)
HB 280	WOOTON	GAMBLING/CHARITABLE Amends law regarding which games may be displayed on video bingo machines
HB 332	PERRY	CRIME/BRIBERY Provides for the forfeiture of property used in connection to the crime of public bribery
