SB 41	MCPHERSON	GAMING Prohibits the extension of a line of credit and the placement of automated teller machines at gaming establishments. (gov sig)
SB 108	MORRISH	PUBLIC SFTY/CORRECT DEPT Places facilities subject to the Judicial Agency Referral Residential Facility Regulatory Act under the jurisdiction of the Department of Public Safety and Corrections, corrections services. (8/15/08)
SB 230	MOUNT	LAW ENFORCEMENT Allows the Louisiana Association of Chiefs of Police Emergency Task Force to render mutual aid under certain conditions. (gov sig)

SB 298	DORSEY	ALCOHOLIC BEVERAGES Provides relative to local permits for the sale of alcoholic beverages. (8/15/08)
SB 400	GRAY	JUVENILE JUSTICE Provides for eligibility for parole of certain juvenile offenders
SB 439	DORSEY	ALCOHOLIC BEVERAGES Provides relative to wholesale and retail dealer's permits for the sale of alcoholic beverages. (8/15/08)
SB 717	MARTINY	CRIMINAL PROCEDURE Provides for blood and saliva testing of a person when there is a bill of information or indictment against such person for certain offenses. (8/15/08)
SB 729	DORSEY	GAMING Authorizes the governing authority of East Baton Rouge Parish to levy a 6% of the monthly net gaming proceeds from each riverboat located within its jurisdiction. (8/15/08)
SB 739	SHEPHERD	GAMING Levies an additional boarding fee on riverboats located in Jefferson Parish, creates special fund in state treasury, and provides for the use of funds derived therefrom. (8/15/08)
SB 773	MARTINY	GAMING Provides for the issuance of alcohol permits to certain facilities which are leased for the purpose of conducting charitable games of chance. (8/15/08)
SB 797	MCPHERSON	GAMING Provides that any casino advertising winnings as a result of gambling also advertise the losses generated during the same period. (8/15/08)
SB 799	MCPHERSON	LAW ENFORCEMENT Prohibits quotas for law enforcement officers. (gov sig)
HB 268	GUILLORY, ELBERT	CORRECTIONS/PRISONERS Amends provisions of law regarding eligibility to participate in work release programs
HB 286	MORRELL	CRIME/DOGFIGHTING Amends provisions of law regarding dogfighting
HB 334	GUILLORY, ELBERT	CORRECTIONS Enacts the Inmate Rehabilitation and Workforce Development Act
