- SB 143 GAUTREAUX, N. CRIME/PUNISHMENT** Prohibits a "sex offender" from wearing a mask, hood or disguise during holiday events and from distributing candy or other gifts on Halloween to persons under eighteen years of age.
- SB 144 GAUTREAUX, N. SEX OFFENSES** Authorizes the administration of medroxyprogesterone acetate to or voluntary castration of persons convicted of a crime which classifies the convicted person as a "sex offender." (gov sig)
- SB 191 DUPLESSIS CRIME/PUNISHMENT** Provides relative to residential mortgage fraud. (gov sig)

- SB 237 THOMPSON CRIME/PUNISHMENT** Provides relative to the definition of criminal abandonment.(gov sig)
- SB 263 SMITH, JOHN CRIME/PUNISHMENT** Provides for the crime of jumping bail. (8/15/08)
- SB 306 QUINN CRIME/PUNISHMENT** Provides that obstruction of justice shall include knowingly and intentionally providing false information to a law enforcement officer. (8/15/08)
- SB 469 DUPRE CRIMINAL PROCEDURE** Provides for sentencing of adults for certain crimes committed as a child. (8/15/08)
- SB 474 GRAY CRIMINAL PROCEDURE** Provides for procedure to determine mental capacity to proceed to trial. (gov sig)
- SB 511 AMEDEE CRIME/PUNISHMENT** Provides for the fines and penalties for the crime of gambling by computer. (gov sig)
