SB 4	SHEPHERD	CRIMINAL PROCEDURE Requires registration and public notice for identity theft offenders. (gov sig)
SB 59	SHEPHERD	CRIMINAL PROCEDURE Authorizes the court to set aside a sentence after completion of probation in misdemeanor or felony cases. (gov sig)
SB 74	SHEPHERD	LAW ENFORCEMENT Prohibits evidence from a traffic camera from becoming part of vehicle operator's driving record.
SB 191	DUPLESSIS	CRIME/PUNISHMENT Provides relative to residential mortgage fraud. (gov sig)

- SB 225** **SHEPHERD** **CRIME/PUNISHMENT** Creates the crime of unlawfully wearing clothing which exposes undergarments or body parts. (gov sig)
- SB 386** **HEBERT** **MILITARY AFFAIRS** Provides certain privileges to certain persons on active military duty or honorably discharged from the United States Armed Forces or the National Guard of any state. (8/15/08)
- SB 500** **CROWE** **INTERNET** Provides for child Internet safety. (8/15/08)
- SB 597** **SCALISE** **CRIMINAL PROCEDURE** Requires a contradictory hearing before a second magistrate can lower the bail originally set by another magistrate. (8/15/08)
