SB 386 HEBERT

MILITARY AFFAIRS Provides certain privileges to certain persons on active military duty or honorably discharged from the United States Armed Forces or the National Guard of any state. (8/15/08)

HCR 143 HARDY

CRIMINAL/SENTENCING Requests DPS&C to study the feasibility of using military service as an alternative to incarceration for certain offenses

- HB 726 HARDY CRIME** Creates the crime of public display of a noose with the intent to intimidate
- HB 1134 GISCLAIR CRIME/SEX OFFENSES** Authorizes the use of polygraphs as a condition of probation or parole of sex offenders
- HB 1243 LAFONTA CRIME/THEFT** Provides for the crime of theft of copper from a religious building or cemetery or graveyard
- HB 1259 EDWARDS CRIMINAL/RECORDS** Exempts payment of fee for expungement of arrest records in certain cases
- HB 1373 BALDONE SEX OFFENSE/REGISTRY** Provides for revisions to the sex offender registration and notification provisions
- HB 1374 NORTON CRIME** Prohibits the participants in a crime from posting their criminal activity on the Internet
