**MILITARY AFFAIRS** Provides certain privileges to certain persons on active military duty or honorably discharged from the United States Armed Forces or the National Guard of any state. (8/15/08)

**HB 39 HAZEL**

**CRIMINAL/PROCEDURE** Adds battery of a police officer and battery of a correctional facility employee to the list of crimes of violence

<b>HB 40</b>	<b>HAZEL</b>	<b>CRIME/SEX OFFENSES</b> Provides with respect to crimes involving prostitution
<b>HB 73</b>	<b>BADON, AUSTIN</b>	<b>CRIME</b> Creates the crime of illegally supplying a felon with ammunition
<b>HB 241</b>	<b>WOOTON</b>	<b>CRIME</b> Creates the crime of forged insurance documents
<b>HB 251</b>	<b>WOOTON</b>	<b>PARDON/PAROLE</b> Amends provisions of law regarding a conviction while on parole
<b>HB 391</b>	<b>WOOTON</b>	<b>SEX OFFENSE/REGISTRY</b> Provides with respect to the failure to pay the sex offender registration fee
<b>HB 394</b>	<b>GREENE</b>	<b>CRIME/HOMICIDE</b> Provides with respect to criminal penalties of negligent homicide
<b>HB 400</b>	<b>WOOTON</b>	<b>CRIME</b> Amends alteration of motor vehicle identification information
<b>HB 413</b>	<b>WOOTON</b>	<b>CRIME</b> Creates the crime of theft of a motor vehicle
<b>HB 434</b>	<b>WOOTON</b>	<b>CRIMINAL/PENALTIES</b> Provides with respect to securities violations
<b>HB 478</b>	<b>BURNS, HENRY</b>	<b>CRIME</b> Provides for resisting an officer with force or violence
<b>HB 586</b>	<b>HARDY</b>	<b>CRIMINAL/PROCEDURE</b> Amends witness protection provisions
<b>HB 654</b>	<b>WOOTON</b>	<b>CRIME/THEFT</b> Provides with respect to offenses against property
<b>HB 751</b>	<b>WOOTON</b>	<b>CRIME/RACKETEERING</b> Adds the crime of identity theft to the Louisiana Racketeering Act
<b>HB 752</b>	<b>MONICA</b>	<b>CRIME</b> Amends criminal penalties for the crime of injuring or killing of a police animal
<b>HB 786</b>	<b>PONTI</b>	<b>DWI</b> Provides with respect to penalties for offenses involving operating a vehicle while intoxicated

- HB 1203 HAZEL** **CRIME/THEFT** Provides with respect to the theft of timber
- HB 1311 PONTI** **WEAPONS** Authorizes U.S. attorneys, U.S. assistant attorneys, and investigators to carry concealed weapons
- HB 1324 JACKSON, G.** **CRIME/SEX OFFENSES** Amends the provisions of felony and misdemeanor carnal knowledge of a juvenile
- HB 1359 JACKSON, G.** **SEX OFFENSE/REGISTRY** Provides with respect to persons convicted of carnal knowledge of a juvenile
