<b>SB 224</b>	<b>SHEPHERD</b>	<b>HOUSING</b> Requires that the board of each housing authority include at least one tenant. (gov sig)

- SB 396**    **HEBERT**                    **PUBLIC CONTRACTS**    Provides for certain restrictions for local governments contracting with private companies for a fee or contingency basis. (6/1/08)
- SB 444**    **HEBERT**                    **INSURERS**    Adds Louisiana Insurance Guaranty Association to the exempt status for appeal bonds. (8/15/08)
- SB 525**    **ERDEY**                    **LOCAL AGENCIES**    Requires parishes and municipalities to comply with federal flood plain management and flood insurance programs prior to construction of local flood protection or storm damage reduction projects. (7/1/08)
