<b>HB 401</b>	<b>MORRELL</b>	<b>DISTRICTS/TAXING</b> Creates the Gentilly Taxing District in Orleans Parish
<b>HB 591</b>	<b>DANAHAY</b>	<b>POLICE/LOCAL</b> Provides relative to the salaries of certain members of the police department of the city of Sulphur
<b>HB 750</b>	<b>LAMBERT</b>	<b>DISTRICTS/SPECIAL</b> Corrects statutory references

- HB 903 LORUSSO PROPERTY/SUBSTANDARD** Authorizes certain agencies and entities in Orleans Parish to enforce health, safety, and welfare statutes and ordinances in any court of competent jurisdiction and establishes an environmental docket in the Civil District Court for the parish of Orleans to hear any such matter
- HB 928 JONES, SAM CULTURE/REC/TOUR DEPT** Provides for the creation of the Louisiana Historic Cemetery Register
- HB 936 LEGER LOCAL FINANCE/BUDGET ACT** Relative to budgets of local entities, provides for inclusion as expenditures of payment of judgments and settlements and prohibits borrowing for capital expenditures when current expenditures are not timely paid
- HB 970 HONEY CIVIL SERVICE/FIRE & POL** Provides relative to holiday compensation of firemen and policemen employed by certain municipalities
- HB 1108 BARROW PARISH/EAST BATON ROUGE** Provides relative to the East Baton Rouge Redevelopment Authority
- HB 1235 LEGER SEWERAGE/N O WATER BD** Provides relative to water service provided by the Sewerage and Water Board of New Orleans
- HB 1267 MONTOUCET COURTS/CITY** Authorizes an increase in compensation for the marshal of the City Court of Rayne
- HB 1297 BARROW HOUSING** Authorizes parish and municipal ordinances to secure or condemn and demolish and remove structures that endanger the public health and welfare, including payment of costs, and provides for national guard assistance
- HB 1304 BALDONE DISTRICTS/SPECIAL** Authorizes increase in per diem for the board of commissioners of recreation districts in certain parishes
