SB 748	DORSEY	TAX/TAXATION Creates the Thomas H. Delpit Area Special District in the parish of East Baton Rouge and grants it certain TIF and tax authority to finance economic development projects within the district. (7/1/08)
SB 755	HEBERT	HOUSING Provides relative to the Louisiana Road Home Housing Corporation Act. (8/15/08)
SB 767	MARIONNEAUX	MUNICIPALITIES Provides relative to withdrawal from the Louisiana Municipal Natural Gas Purchasing and Distribution Authority (8/15/08)
HB 49	SMITH, GARY	DISTRICTS/HOSPITAL SERVC Provides relative to per diem for hospital service district commission members in St. Charles Parish
HB 50	ELLINGTON	TAX/SALES-USE, LOCAL Authorizes the governing authority of the city of Winnsboro to levy and collect an additional sales and use tax
HB 51	ELLINGTON	TAX/HOTEL OCCUPANCY Authorizes the governing authority of the city of Winnsboro to levy and collect a hotel occupancy tax subject to voter approval
HB 54	GUILLORY, MICKEY	HOUSING/AUTHORITIES Requires a local housing authority to enter into an employment contract with the executive director of the housing authority
HB 203	ST. GERMAIN	BOARDS/COMMISSIONS Repeals the sunset of the Atchafalaya Trace Commission
HB 252	PUGH	LOCAL OFFL/POLICE CHIEFS Provides relative to the powers of the police chief in the city of Ponchatoula
HB 300	DOWNS	FUNDS/FUNDING Provides relative to the disposition of monies in the Lincoln Parish Municipalities Fund

- HB 311 SMITH, GARY PLANNING/ZONING-LOCAL** Authorizes an increase in per diem for members of the zoning commission in St. Charles Parish
- HB 354 PERRY ASSESSORS** Provides for the payment of certain insurance premium costs for certain retired assessors and assessors' employees in certain parishes
- HB 620 LORUSSO PARKS** Relative to audits concerning New Orleans City Park and the New Orleans City Park Improvement Association and its board, provides for the respective responsibility of the park, the association, and its board, and of the Department of Culture, Recreation and Tourism relative to such audits
- HB 668 DOWNS EMPLOYMENT** Provides relative to post-employment benefit funds established by political subdivisions
- HB 1032 LORUSSO DISTRICTS/NEIGHBORHOOD** Creates the Mid-City Security District in Orleans Parish
- HB 1144 MONTOUCET TAX/SALES-USE, STATE** Dedicates the state sales tax on hotel occupancy in Acadia Parish to the Acadia Parish Convention and Visitors Commission
