SCR 10	MCPHERSON	HUNTERS/HUNTING Requests the Wildlife and Fisheries Commission to promulgate rules allowing a WMA hunting permit fee exemption for small game hunters during the first nine days of the regular squirrel season.
SB 13	DUPRE	FISH/FISHING Changes the number of hoop nets allowed with a recreational gear license. (gov sig)
SB 20	DUPRE	FISH/FISHING Provides relative to trawling vessels. (8/15/08)
SB 22	DUPRE	FISH/FISHING Provides relative to required finfish stock assessment report. (8/15/08)

SB 25	DUPRE	SPECIAL DISTRICTS Creates the Terrebonne Parish Veterans' Memorial District. (gov sig)
SB 48	MCPHERSON	WATER/WATERWAYS Includes certain waters within state natural and scenic rivers system. (gov sig)
SB 67	DUPRE	WILDLIFE/FISHERIES DEPT Re-creates the Department of Wildlife and Fisheries. (6/30/08)
SB 68	DUPRE	HUNTERS/HUNTING Allows military personnel and POST-certified law enforcement personnel to file for firearm and hunter education exemption at certain offices. (8/15/08)
SB 124	DUPRE	NATURAL RESOURCES DEPT Re-creates the Department of Natural Resources.
SB 242	MCPHERSON	PUBLIC PROPERTY Authorizes the transfer of certain state property, located in Rapides Parish, from the Department of Health and Hospitals to the Department of Transportation and Development.
SB 270	MCPHERSON	PUBLIC PROPERTY Authorizes the transfer of certain state property, located in Rapides Parish, from the state of Louisiana, from the Department of Health and Hospitals, to the Department of Transportation. (gov sig)
SB 281	CROWE	FEES/LICENSES/PERMITS Provides for fishing licenses of minors with valid identification card.
SB 283	CROWE	BOATS/BOATING Names the boat launch at US-90 and Pearl River in Slidell as "Edward C. Scogin Memorial Boat Launch."
SB 305	DUPRE	WILDLIFE/FISHERIES DEPT Provides relative to certain leases granted by the Department of Wildlife and Fisheries. (8/15/08)
SB 344	GAUTREAUX, N.	TAX EXEMPTIONS Exempt from property tax inventories of oilfield tubulars if they are inspected and certified as safe for use in critical locations as provided by law. (See Act)

- SB 365** **DUPRE** **GOVERNMENT ORGANIZATION** Provides relative to the Louisiana Environmental Education Act. (gov sig)
- SB 371** **DUPRE** **FUNDS/FUNDING** Provides relative to the Aquatic Plant Control Fund. (8/15/08)
- SB 676** **LAFLEUR** **PUBLIC BUILDINGS/GROUNDS** Designates the visitor center at the Louisiana State Arboretum as the J. D. "Prof" Lafleur Visitors Center. (8/15/08)
