conversion of certain storage caverns in the Jefferson Island salt dome. (8/15/08)

- SB 325**     **ADLEY**     **WILDLIFE/FISHERIES DEPT** Provide relative to the powers and duties of the Wildlife and Fisheries Commission. (gov sig)
- SB 352**     **GAUTREAUX, N.**     **PUBLIC LANDS** Authorizes the transfer of certain state property to the Vermilion Parish School Board. (8/15/08)
