


SB 292	MCPHERSON	FISH/FISHING Allows access to the ordinary high stage of navigable waters for certain purposes. (8/15/08)
SB 293	MCPHERSON	WATER/WATERWAYS Provides relative to the banks of navigable rivers or streams. (8/15/08)
SB 349	DUPRE	COASTAL RESOURCES Provides relative to lands acquired by the state or political subdivision. (See Act)
SB 731	DUPRE	PUBLIC PROPERTY Authorizes the transfer of certain state properties in the parish of East Baton Rouge. (gov sig)
SB 744	DUPRE	FISH/FISHING Requires charter boat fishing guide licensees to provide certain information to the Department of Wildlife and Fisheries. (8/15/08)

- SB 763 DONAHUE PUBLIC LANDS** Authorizes the transfer of certain state property in St. Tammany Parish. (gov sig)
- SB 800 MCPHERSON PUBLIC LANDS** Provides relative to certain leases granted by a state department. (8/15/08)
- HCR 28 FOIL WILDLIFE & FISHERIES** Requests the Dept. of Wildlife and Fisheries to study Bayou Manchac for possible inclusion in the Louisiana Historic and Scenic River system
- HB 175 MILLS PROPERTY/PUBLIC** Authorizes the transfer or lease of certain state property in St. Martin Parish from the division of administration to the adjacent landowners
- HB 476 FANNIN PROPERTY/PUBLIC** Provides relative to property transfers from the Dept. of Culture, Recreation and Tourism to DOTD
- HB 477 DIXON PROPERTY/PUBLIC** Provides relative to property transfers from DHH to DOTD
- HB 615 DIXON PROPERTY/PUBLIC** Provides relative to property transfer from DHH to DOTD
- HB 1046 ST. GERMAIN PUBLIC LANDS/STATE** Authorizes the transfer of certain property from the division of administration to DOTD
- HB 1142 ST. GERMAIN FISHING/OYSTERS** Authorizes the Wildlife and Fisheries Commission to develop and implement rules for the use of oyster cargo vessels
