III. LEGISLATION TO BE CONSIDERED:

SB 9 MARIONNEAUX TAX/INCOME/PERSONAL Provides that the deduction from Louisiana income for federal income taxes will not decrease because of federal income tax rebates and credits received in 2008 from the federal Economic Stimulus Act of 2008. (8/15/08)

SB 10 MARIONNEAUX TAX/FRANCHISE/CORPORATE Accelerates the phase-out of corporate franchise tax on "borrowed capital" by one year, by excluding all "borrowed capital" from "taxable capital" for tax years beginning in 2011 (instead of 2012) and thereafter. (See Act)

SB 12 MARIONNEAUX TAX/SALES Accelerates the phase-out of state sales taxes on manufacturing machinery and equipment by one year, making the purchase or lease of such machinery and equipment beginning 7/1/09 and thereafter tax free. (7/1/08)

SB 13 MARIONNEAUX TAX/SALES Removes the "permanent penny" on purchases of utilities by businesses. (7/1/08)
