

III. LEGISLATION TO BE CONSIDERED:

**SB 28 MURRAY**

**TAX/AD VALOREM** Constitutional amendment to replace the New Orleans City Council with the Tax Commission as the board of review for ad valorem property tax assessments. (1/1/09) (2/3 - CA13s1(A))

**SB 29 MURRAY**

**TAX/AD VALOREM** Provides for the Louisiana Tax Commission instead of the parish governing authority to be the board of review to determine the correctness of property tax assessments in certain parishes. (See Act)

**SB 109 MORRISH**

**CAPITAL OUTLAY** Increases the amount for projects for minor repairs, renovation, or construction of facilities or purchase of land and facilities which may be undertaken outside of the capital outlay process by higher education.

**SB 520 MORRISH**

**TAX/TAXATION** Prohibits an action to collect a state motor vehicle tax or a state tax applicable to movables on the purchase of manufactured homes used as residential housing until July 1, 2009, if the basis of such action is the date upon which a declaration of immovability is recorded in the conveyance or mortgage records. (gov sig)
