SCR 5 CHAISSON

COURTS Urges and requests the Louisiana Supreme Court to adopt the same financial disclosure standards for judges that are applicable to other elected officials in the Code of Governmental Ethics.

- SR 3** **CHAISSON** **SENATE** Provides relative to standing committee jurisdiction of Natural Resources Committee and Transportation, Highways and Public Works Committee.
- SR 6** **CHAISSON** **COURTS** Urges and requests the Louisiana Supreme Court to adopt the same financial disclosure standards for judges applicable to elected officials in the Code of Governmental Ethics.
- SB 8** **CHAISSON** **LOBBYING** Prohibits acceptance of more than \$50 per occasion on food, drink or refreshments by public servants. (gov sig)
- SB 9** **CHAISSON** **LOBBYING** Requires lobbyists to file monthly expenditure reports and to disclose expenditures in excess of \$50 in the aggregate on public servants. (See Act)
- SB 10** **CHAISSON** **LOBBYING** Prohibits certain conduct by lobbyists. (See Act)
- SB 11** **CHAISSON** **LOBBYING** Provides relative to lobbyist registration and expenditure report requirements. (1/1/09)
