ELECTION CODE Establishes a special committee to study the Election Code.

SB 53 SHAW

ETHICS Provides that any complaint filed anonymously with the Board of Ethics shall not be investigated or addressed by the board. (8/15/08)

- SB 115** **MARTINY** **ELECTION CODE** Provides a procedure for qualifying as a candidate by nominating petition whenever qualifying is reopened for an office after the death of a candidate. (7/1/08)
- SB 189** **MARIONNEAUX** **APPOINTED OFFICIALS** Provides for automatic removal of appointees not reappointed by the governor. (8/15/08)
- SB 210** **MARIONNEAUX** **APPOINTED OFFICIALS** Provides that certain persons appointed to boards and commissions be reconfirmed each legislative term. (8/15/08)
- SB 223** **SHEPHERD** **LEGISLATORS** Provides relative to funding for legislative assistants. (7/1/08)
- SB 271** **DONAHUE** **ELECTION DAYS** Reduces the number of days on which certain elections may be held. (1/1/09)
- SB 296** **ADLEY** **LEGISLATIVE SESSIONS** Constitutional amendment to require that the proclamation calling for an extraordinary session be issued and made public so that at least five calendar days elapse after the day the proclamation is made public and prior to the day of the start of the session. (2/3-CA13s1(A))
- SB 596** **SCALISE** **APPOINTED OFFICIALS** Revises the laws regarding the state inspector general. (8/15/08)
