SB 14	DUPRE	PUBLIC CONTRACTS Changes the termination date for contracts awarded for the restoration and rehabilitation of certain levees from 2008 to 2010. (gov sig)
SB 15	DUPRE	MOTOR VEHICLES Authorizes the issuance of a "Gold Star" motor vehicle prestige license plate.
SB 116	MARTINY	ROADS/HIGHWAYS Re-names a certain portion of the West Bank Expressway as the Harry Lee Expressway.
SB 121	DUPRE	PUBLIC CONTRACTS Increases the contract limit amount for which the public bid process is required to \$200,000. (08/15/08)
SB 412	MCPHERSON	TRANSPORTATION/DEV DEPT Provides relative to notice requirements for Department of Transportation bids for purchases. (7/1/08)

SB 484	MCPHERSON	WEIGHTS/MEASURES Reinstates "mobile" weight enforcement within DOTD. (7/1/08)
SB 491	MCPHERSON	PUBLIC CONTRACTS Changes authorization for utilizing design-build contracts by the Department of Transportation and Development from a limited duration pilot program evaluating to their effectiveness to a permanent program. (7/1/08)
SB 493	MCPHERSON	TRANSPORTATION/DEV DEPT Provides for records of "safety sensitive infrastructure" of DOTD. (7/1/08)
SB 503	MCPHERSON	TRANSPORTATION/DEV DEPT Repeals the adopt-a-road program in DEQ and reestablishes the program in DOTD. (gov sig)
SB 547	MCPHERSON	TRANSPORTATION/DEV DEPT Repeals provision requiring immovable property expropriated by DOTD which has not been used for departmental purposes within 15 years of the date of expropriation to be declared excess property and sold to the original owner at original cost. (7/1/08)
