| SB 274 | MOUNT | DWI Authorizes the Department of Public Safety and Corrections to use certification by certain professional organizations in determining the qualifications and competence of individuals and labs to administer tests on suspected impaired drivers and requires the admissibility of such tests in court. (8/15/08) |
| SB 275 | MOUNT | MOTOR VEHICLES Authorizes, subject to the adoption of school board policies, the denial or suspension of driving privileges to a minor who fails to meet compulsory school attendance requirements and has withdrawn from school or is habitually absent or truant. (8/15/08) |
| SB 341 | ERDEY | TRAFFIC Prohibits certain trucks from using the far left lane on highways with three or more lanes of traffic moving in the same direction. (8/15/08) |

- SB 494 ERDEY DWI** Provides relative to certification of ignition interlock devices and their manufacturers and installers. (08/15/08)
- SB 547 MCPHERSON TRANSPORTATION/DEV DEPT** Repeals provision requiring immovable property expropriated by DOTD which has not been used for departmental purposes within 15 years of the date of expropriation to be declared excess property and sold to the original owner at original cost. (7/1/08)
- SB 771 HEBERT MOTOR VEHICLES** Authorizes the use of mini-trucks on streets and highways at speeds not to exceed 45 mph. (8/15/08)
- SB 789 HEBERT ROADS/HIGHWAYS** To provide for additional members from certain parishes to certain commissions. (8/15/08)
- SB 793 SHEPHERD FEES/LICENSES/PERMITS** Authorizes prestige license plate for New Home Ministries Community Development Corporation. (8/15/08)
