SB 743	CHEEK	MOTOR VEHICLES Requires each coroner to report to DOTD all deaths of people under 16 related to the operation of off-road vehicles. (8/15/08)
HB 373	HAZEL	MTR VEHICLE/LICEN PLATES Establishes the "Iraq Campaign Veteran" and "Afghanistan Campaign Veteran" military plates
HB 402	FOIL	MTR VEHICLE/BUSES-SCHOOL Prohibits school bus operators from using cell phones while driving
HB 544	HUTTER	TRANSPORTATION DEPT Expands authority of the Department of Transportation and Development for design-build contracts
HB 566	HUTTER	PUBLIC CONTRACT/BIDS Authorizes a notice when the purchase exceeds twenty-five thousand dollars to persons who furnish commodities by notice sent through an electronic interactive environment

HB 590	HUTTER	PORTS/HARBORS/TERMINALS Authorizes the St. Bernard Port, Harbor, and Terminal District to acquire certain property
HB 656	SIMON	DISTRICTS/SPECIAL Provides that each member of the Zachary Taylor Parkway Commission shall be appointed by his parish president or by the president of the police jury if there is no parish president
HB 784	HUTTER	MTR VEHICLE/DRIVER LIC Provides relative to the requirements for certain classes of commercial driver's licenses
HB 785	HUTTER	MTR VEHICLE/COMMERCIAL Provides relative to violations of the operation of commercial motor vehicles
HB 791	HUTTER	PROPERTY/EXPROPRIATION Provides with respect to expropriated property of DOTD not used for projects in a certain time period
HB 839	HUTTER	MTR VEHICLE/WINDSHIELDS Prohibits owners or operators of vehicles with an approved Medical and Security Exemption Affidavit from placing window tint on an entire windshield of a vehicle
HB 1081	SCHRODER	HIGHWAYS Authorizes the sale of state bridges under certain circumstances with the prior approval of the legislature
HB 1119	CHANEY	FUELS/LIQ PETROLEUM GAS Increases per diem for members of the Louisiana Liquefied Petroleum Gas Commission
