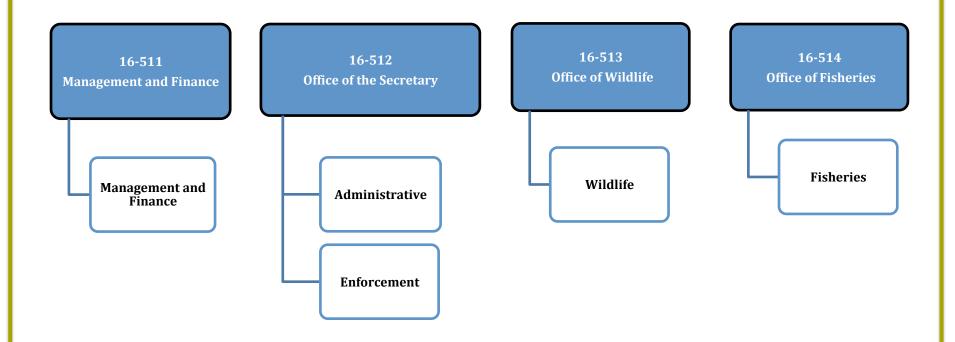

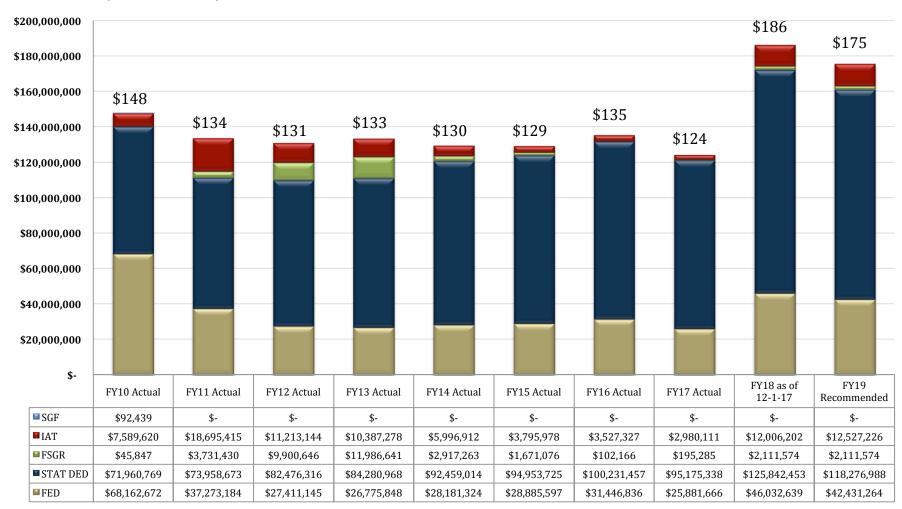




Wildlife and Fisheries Changes in Funding since FY10

Total Budget by Fiscal Year and Means of Finance (in \$ millions)

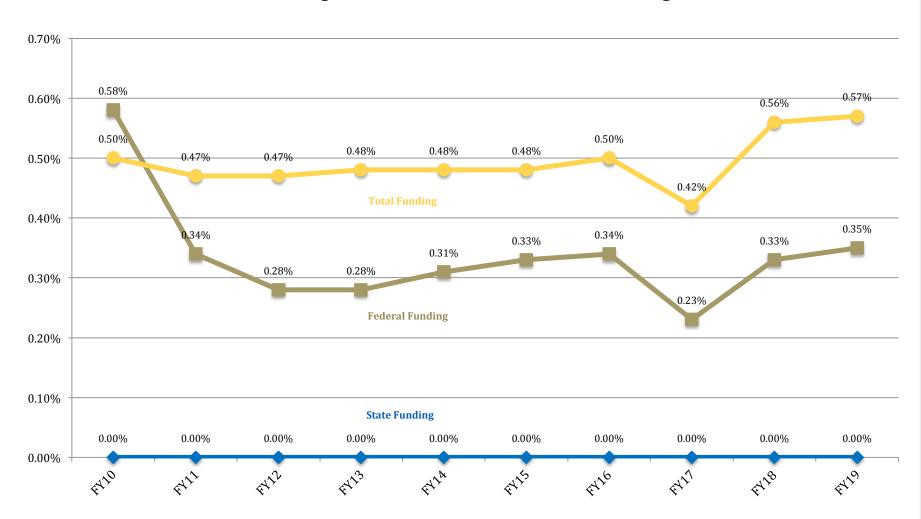

WFIS Changes in Funding since FY10

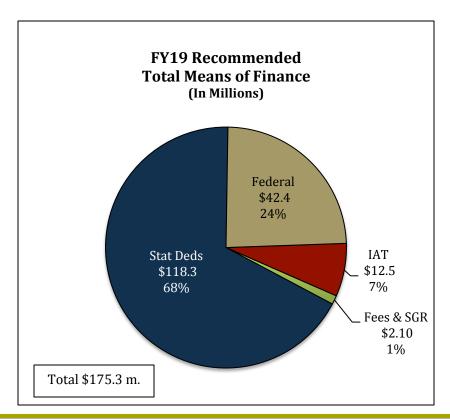
WFIS' Budget as a Portion of the Total State Budget

Non-SGF Sources of Funding:

This department has no State General Fund for FY19.

Statutory Dedications and Federal Funds are the two primary sources of revenue.

Statutory Dedications, which make up sixty-eight percent of the department's total funding, are derived from severance taxes, royalties on land and minerals, leases, licenses, fees, etc. and distributed into the Conservation Fund, which is the largest of the thirty-three statutorily dedicated funds of which the department receives funding.

Federal Funds are derived from the U.S. Department of Commerce, U.S. Department of Interior, U.S. Coast Guard, U.S. Fish and Wildlife and Sport Fish and Wildlife Restoration, and U.S. Homeland Security.

Wildlife and Fisheries Conservation Fund

The Wildlife and Fisheries **Conservation Fund** (La. Const. Art. VII, Section 10-A) is a constitutionally protected fund containing revenues derived from fees, licenses, permits, and royalties.

- The Fund shall be used solely for the programs and purposes of conservation, protection, preservation, management, and replenishment of the state's natural resources and wildlife, including use for land acquisition or for federal matching fund programs which promote such purposes, and for the operation and administration of the Department and the Wildlife and Fisheries Commission, or their successors.
- The FY19 Recommended funding for the Conservation Fund is \$83.7 million.

The department relies heavily (68%) on dedications to fund department activities. If the largest source of that dedication, the Conservation Fund, does not increase in excess of annual expenditures, the Department of Wildlife and Fisheries' primary revenue source could be depleted.

HB 687 by **Representative Zeringue** would have restructured hunting and fishing licensing for the Department. The fiscal note projected it would increase statutory dedications. It failed to receive a two-thirds vote on the House Floor.

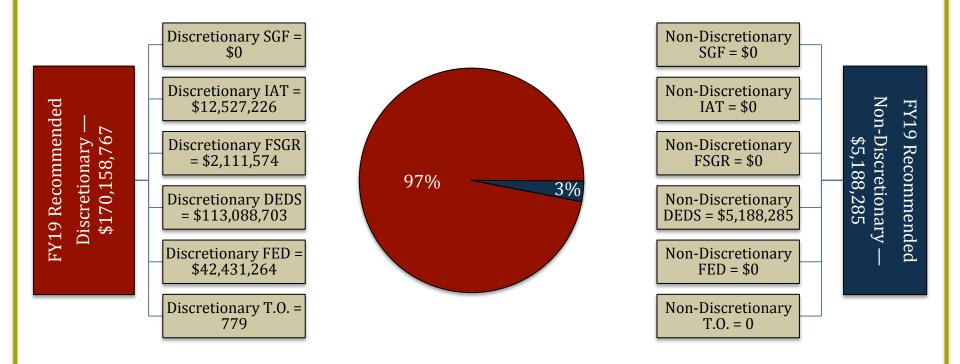

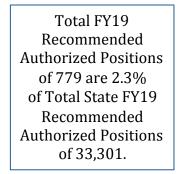

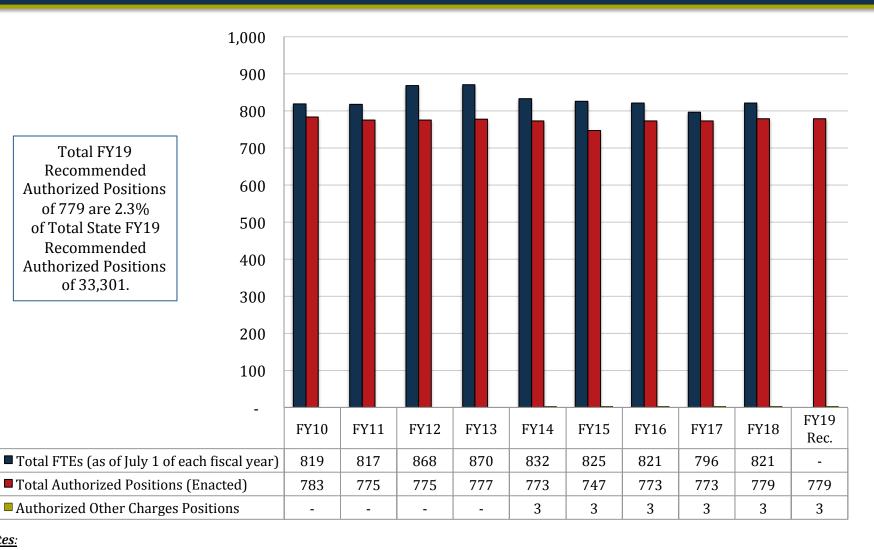
