

Agency	Program Description
Management and Finance	Provides management and finance administration, support services, and the Office of Legal Affairs.
OSP - Traffic Enforcement	Patrols state roads and enforces statutes and regulations; enforces laws governing commercial motor carriers; provides the La. Oil Spill Coordinator's Office.
OSP - Criminal Investigation	Provides criminal investigation activities, insurance fraud investigations, and investigative support.
OSP - Operational Support	Houses the Office of the Superintendent, operational development and planning, support services, the Crime Lab, Protective Services, and DPS police services.
OSP - Gaming Enforcement	Enforces regulations in the gaming industry, including licensing of gaming operations and ensuring the integrity of gaming devices and systems.
OMV - Licensing	Provides motor vehicle administration, issuance of driver's licenses and ID cards, issuance of plates and titles, and suspension of driver's licenses and revocation of plates.



Total Budget by Fiscal Year and Means of Finance (in \$ millions)




Public Safety Changes in Funding since FY11

Non-SGF Sources of Funding:

Fees and Self-generated Revenues constitute the largest portion of DPS funding at 45 percent. These funds are derived from several sources, such as OMV fees (drivers' licenses, registration, etc.), Fire Marshal fees, and other misc. fees.

Statutory Dedications make up a significant funding source in Public Safety at 38 percent.

The five largest Statutory Dedications sources include:

Riverboat Gaming Enforcement Fund	\$63.6 m.
Insurance Verification System Fund	\$32.3 m.
Louisiana Fire Marshal Fund	\$17.3 m.
Louisiana State Police Salary Fund	\$15.6 m.
Criminal Identification and Information Fund	\$8.5 m.

Interagency Transfers come from OJJ and GOHSEP for back office functions, DOTD for weights and standards policing, security expenses charged to other state agencies, LCLE and GOHSEP grants, insurance recovery, etc.

Federal Funds are derived from the U.S. Departments of Transportation, Justice, Housing and Urban Development, and the EPA, DEA, and FBI.



Public Safety FTEs, Authorized Positions, and Other Charges Positions





Continuation Budget, Standstill Budget, and Proposed Budget

Continuation and Standstill budgets for Public Safety include recommendations of \$1.5 million for Inflation costs offset by non-recurring carryforwards of \$51,504. In the FY20 Proposed Budget, \$0 in State General Fund is recommended for Public Safety.

Difference between the Governor's Proposed Budget (HB 103 by Rep. Leger) and House Bill No. 105 by Rep. Henry

For this department, there is no difference between the FY20 budget proposed by the governor (HB 103) and the amount contained in HB 105. The \$51,504 SGF from FY19 EOB is a non-recurring carryforward.

Public Safety Budget Issues for FY20

State Police Overtime Pay

- Overtime pay was reduced by roughly \$3.5 million/\$4 million in FY19
- Overtime pay for FY20 is proposed at \$14.8 million
 - FY20 expenses for overtime are projected to be as high as \$22 million, leaving a potential need of over \$7 million

Staffing Shortages at OMV Field Offices

- Position reductions over the last 10 years have cut staff by 31.7 percent
 - FY09 Actual T.O. = 738; FY19 EOB T.O. = 504
 - Fewer staff lead to increased wait times for citizens
- Twenty (20) T.O. needed to manage the International Registration Plan program within OMV
 - The program had been outsourced to Xerox, but the company is no longer willing to provide specified services
 - Staff pulled from other field offices to administer the program

No funding for trooper cadet class for FY20

Shortage in Fire Marshal Fund

- \$3.5 million reduction in FY20 Proposed
 - REC Forecast number increases initial reduction of \$2.7 million by about \$800 k.
 - \$700 k. reduction in FY19
- Yearly increases in Statewide Adjustments continue to cut into the fund
 - · No new budget requests have been funded



Public Safety – Audit Findings

Public Safety Services

December 10, 2018

Department of Public Safety (DPS) employees did not follow policies to ensure their time sheets were accurate, timely certified, properly approved, and reflected hours actually worked. Also, employees did not adhere to department policies and procedures requiring adequate support and timely review of purchases made on the LaCarte card and ensuring that purchases were not artificially divided. In addition, DPS officials could not provide documentation showing that \$2.4 million from the New Orleans Public Safety Fund was spent for public safety services in the New Orleans area as required. The Office of State Police also did not ensure all property purchased was properly tagged, timely recorded in the state property system, and properly safeguarded in accordance with state property regulations. The Office of the State Fire Marshal did not have adequate controls in place to ensure all amusement ride inspection fees were collected, appropriately supported, and timely deposited in accordance with state regulations. For the third consecutive year, DPS failed to ensure funds were drawn down according to federal regulations for the Alcohol Open Container Requirements and the Minimum Penalties for Repeated Offenders for Driving While Intoxicated programs. The audit report also noted an Office of Motor Vehicles internal investigation that found \$98,507 in customer payments missing and resulted in three OMV employees being charged with theft. An employee of a Public Tag Agency was charged with computer fraud and filing or maintaining false records, as well. In addition, an internal DPS audit of the Louisiana Highway Safety Commission (LHSC) found multiple issues related to LHSC's federal awards from the National Highway Traffic Safety Administration.
