
FY23 Recommended Budget Schedule 08B — Public Safety Agencies





Non-SGF Sources of Funding:

Fees and Self-generated Revenues constitute the largest portion of DPS funding at 58 percent. These funds are derived from several sources, such as OMV fees (drivers' licenses, registration, etc.), Fire Marshal fees, and other misc. fees. In addition, 15 dedicated funds were reclassified as FSGR fund accounts by Act 114 of the 2021 Regular Session. They are highlighted on the next slide.

Statutory Dedications make up a significant funding source in Public Safety at 27 percent.

The five largest Statutory Dedications sources include:

Riverboat Gaming Enforcement Fund	\$75.0 m.
Louisiana Fire Marshal Fund	\$22.1 m.
Louisiana State Police Salary Fund	\$15.6 m.
Oil Spill Contingency Fund	\$7.5 m.
Video Draw Poker Device Fund	\$7.3 m.

Interagency Transfers come from OJJ and GOHSEP for back office functions, security expenses charged to other state agencies, LCLE and GOHSEP grants, insurance recovery, etc.

Federal Funds are derived from the U.S. Departments of Transportation, Justice, Housing and Urban Development, and the EPA, DEA, and FBI.

The FY23 Recommended Budget for Public Safety is an increase of \$26.3 million over FY22 Enacted. This equates to a percentage increase of 5.5.

The Office of State Police showed the largest increase at \$18.4 million, followed by the Fire Marshal at \$3.4 million, the Office of Motor Vehicles at \$2.6 million, and Management and Finance at \$1.5 million.

The Louisiana Highway Safety Commission (+\$330,217); the Liquefied Petroleum Gas Commission (+\$81,270); and the Gaming Control Board (+\$7,193) also showed increases.

Fees and Self-generated Revenues showed the largest increase at \$69.9 million due to the reclassification of means of finance in Act 114 of the 2021 Regular Session. This Act is also partially responsible for a decrease of \$44.8 million in Statutory Dedications, along with revised REC estimates. State General Fund increased by \$2.8 million and Federal Funds showed a modest increase of \$80,217. Interagency Transfers decreased by \$1.7 million.

Authorized T.O. increased by 38, mainly due to the addition of 30 T.O. in Motor Vehicles and 15 T.O. in the Fire Marshal's Office, partially offset by a reduction of (27) due to the transfer of Stationary Weight Scale Enforcement back to DOTD.



Categorical Expenditures Examples of Categories

Departments expend funding in the five major categories listed below.

Total Other Charges

- Other Charges Aid to school boards, local government, etc.; public assistance; miscellaneous charges; judgments, fines, and penalties; interest on judgments; punitive/compensatory damages; OC personal services, operating expenses, professional services; contract attorney expenses; recoupments; furlough; contractual services; interest expense; claim payments; commercial group insurance; reinsurance; loans issued; disbursements; etc.
- Debt Service Principal, interest, related charges, reserve requirement, amortization, and bond premiums.
- Interagency Transfer Line-Item Expenditure Any expenses paid for with Interagency Transfers from commodities and services to equipment.







Public Safety Categorical Expenditures FY21, FY22, and FY23









The chart above shows projected supplemental FY22 needs in Public Safety by means of financing and agency.

The total requested for the department is \$7.4 million, all of which is projected to come from State General Fund. Major need areas in the department include \$5 million for replacement of the Louisiana Integrated Gaming History Tracking System for casino and video poker information and records; \$1.7 million for replacement of the legacy payment system for municipal police officers and firefighters supplemental pay monthly reporting; and \$701,944 for crime lab equipment.

The other adjustments for the FY22 supplemental bill are means of financing substitutions that have a net zero effect on expenditures.

Additional supplemental needs may be addressed as regular session deliberations begin.





- Administrative Program Promulgates and enforces rules that foster the safest distribution, handling, and usage of liquefied petroleum gas and anhydrous ammonia.





Public Safety – Audit Reports

Louisiana Department of Public Safety and Corrections – Public Safety Services *December 20, 2021*

The Office of Motor Vehicles (OMV) and the Office of the State Fire Marshal (OSFM) did not certify and approve time sheets in a timely manner, as required by DPS payroll policies. This is the fourth consecutive report for the OMV finding.

Also, the Office of State Police (OSP) (for the fourth consecutive report) and OSFM (for the second consecutive report) did not ensure all property purchased was tagged and recorded in the state property system in a timely fashion.

For the second consecutive report, OSP and OSFM did not ensure certain purchases made with the LaCarte card followed state purchasing regulations. In addition, OSP did not deposit fees collected for the Concealed Handgun Permit Fund in a timely manner, as required by state law.

A previous report finding related to untimely deposit of fees of the Liquefied Petroleum Gas Commission Rainy Day Fund was resolved.
