01-124 Louisiana Stadium and Exposition District (LSED)

The Louisiana Stadium and Exposition District (LSED) is a political subdivision of the state. It is governed by a 7-member Board appointed by the Governor. It has ownership of and jurisdictional authority over the facilities shown in this presentation. The Board contracts with ASM Global to provide for the operation of:

Caesars Superdome Smoothie King Center

(Both owned by LSED and leased to the State)

Champions Square

(leased to LSED by Zelia/Benson)

- **New Orleans Saints Training Facility**
 - **TPC Louisiana Golf Course**
- **Shrine on Airline (Baseball Stadium)**
 - **Alario Event Center**

In addition to operating expenses for the facilities, the LSED budget includes required payments in accordance with agreements with the Saints and Pelicans sports teams.

- Caesars Entertainment and the Saints signed a new 20-year, \$138-million deal for naming rights for the Superdome in July 2021.
- The contract was approved by JLCB that month and began in August 2021.
- The deal breaks down to \$6.9 million annually.

- Opened in October 1999 at a cost of \$112 million, including site clearance and preparation.
- It was renovated in 2013 at a cost of \$34 million.
- The Center has flexible seating for up to 17,500 people.





FY27 Significant Adjustments

Significant adjustments include:


- An increase of \$3.1 million to fully fund operating expenses for LSED facilities;
- A reduction of **(\$830,138)** to align with projected payments to the Office of Risk Management premiums; and
- A realignment of \$41,500 in various dedicated funds to fund contractual obligations with the Saints and Pelicans and to align with the most recent adopted REC forecast.



Categorical Expenditures

Examples of Categories

Departments expend funding in the five major categories listed below.

Personal Services

- Salaries – Regular, overtime, and termination pay for Classified and Unclassified personnel.
- Other Compensation – Wages, student labor, compensation for board members and/or board of trustees, evening instruction, university instructors, etc.
- Related Benefits – Retirement contributions, post-retirement contributions/benefits, FICA tax, Medicare tax, group insurance contributions, compensated absences, other related benefits, taxable fringe benefits, etc.

Total Operating Expenses

- Travel – In-state and Out-of-state, including meal reimbursement.
- Operating Services – Advertising, printing, insurance, maintenance, rentals, data processing, internet costs, dues and subscriptions, mail delivery, telephones, data lines, vehicle tracking and telematics, utilities, depreciation, amortization, banking services, credit card fees, etc.
- Supplies – office supplies and equipment, computers, clothing and uniforms, medical, pharmaceutical, food, automotive, repair and maintenance, software, etc.

Professional Services – Accounting, auditing, management consulting, engineering, architectural, legal, medical and dental, veterinary, information technology, etc.

Total Other Charges

- Other Charges – Aid to school boards, local government, etc.; public assistance; miscellaneous charges; judgments, fines, and penalties; interest on judgments; punitive/compensatory damages; OC personal services, operating expenses, professional services; contract attorney expenses; recoupments; furlough; contractual services; interest expense; claim payments; commercial group insurance; reinsurance; loans issued; disbursements; etc.
- Debt Service – Principal, interest, related charges, reserve requirement, amortization, and bond premiums.
- Interagency Transfer Line-Item Expenditure – Any expenses paid for with Interagency Transfers – from commodities and services to equipment.

Acquisitions and Major Repairs

- Acquisitions – Land; buildings; automobiles; aircraft; accessories; equipment; software; hardware; farm and heavy equipment; boats; capital outlay expenditures; construction; etc.
- Major Repairs – Land improvement; buildings; automotive; grounds; boats; aircraft; movable equipment; farm equipment; medical; office; library; education; recreation; communication; other equipment; pollution remediation; etc.





Categorical Expenditures at FY27 Recommended

The largest expenditure category in LSED is Total Other Charges, which makes up 70 percent of total expenditures. These are the team entitlements, capital replacement and repair, management fees, and LSED administrative expenses.

Within this category, Debt Service contributes roughly 24 percent of the budget and is primarily for facility renovations that are secured by the hotel occupancy tax and event revenue. Interagency Transfer Expenses are for the Office of Risk Management.

Operating Services is about 30 percent of the budget and includes facility operating expenses.



- It has ownership of and jurisdictional authority over the facilities shown in this presentation.
- The LSED provides oversight concerning these facilities through the seven-person board listed above, who are appointed by the governor.
- The members of the board have no set term length and serve at the determination of the governor.

ASM Global is the private company responsible for event planning and venue management in LSED facilities. The company has a portfolio of over 300 stadiums, arenas, convention centers, theaters, and other establishments around the world.







LSED Expenses = \$45,766,865





Facility Expenses = \$39,919,480




