As it relates to this section, the term "medical necessity" as applied to benefits for mental illness and substance abuse disorders shall mean reasonable and necessary for the diagnosis of a mental illness or substance abuse disorder, which is furnished in the most appropriate and least restrictive setting in which services can be safely provided, at the most appropriate level or supply of service which can safely be provided and could not have been omitted without adversely affecting the individual's health or the quality of care rendered.

F. This Section shall not be construed as prohibiting a health benefit plan from excluding coverage for diagnosis and treatment of mental illnesses and substance abuse disorders when the diagnosis and treatment are medically unnecessary, provided that the medical necessity determination is made in accordance with generally accepted standards of the medical profession and other applicable laws and regulations.

G. The increase in the cost of the policy shall be capped at and one-half percent per year. The commissioner of one and one-half percent per year. The commissioner of insurance shall promulgate rules in accordance with the Administrative Procedure Act to implement this exemption.
