Such labels shall be easily identifiable and affixed to every package sold. As used in this Section, the following terms shall have the meanings ascribed to them as follows:

**R.S. 56:578.11(A)(1) is all proposed new law.** (1) "Catfish" means only those species within the family Ictaluridae or the family Anarhichadidae.

**R.S. 56:578.11(A)(2) is all proposed new law.** (2) "Catfish product" means any item consisting of or containing catfish and which is intended for human consumption.

**<u>R.S. 56:578.11(A)(3) is all proposed new law.</u>** (3) "Direct retail sale," means the sale, in the state of Louisiana, of any catfish product directly to a consumer.

B. Violation of the labeling requirements of this Section shall subject the distributor or packager to the penalties provided in R.S. 56:578.10(B).

C.(4) As used in this Section, "farm-raised" "Farm-raised catfish means catfish produced using the aquacultural procedure whereby catfish are propagated, maintained, reared, and harvested within artificial reservoirs, tanks, cages, impoundments, or other controlled environments, so as to prevent, at all times, the ingress or egress of animal and plant life from public waters including natural rivers, streams, or lakes. "Farm-raised" shall not include the production and harvesting of catfish in cages or other enclosures located in public waters including natural, lakes, streams, or rivers.

#### R.S. 56:578.11(A)(5) is all proposed new law.

(5) "Label" means any display of written, printed or graphic matter upon or affixed to the catfish product or to its container, covering, package, or wrapping

**R.S. 56:578.11(A)(6) is all proposed new law.**(6) "Wild catfish" means any catfish that has been caught in or removed from any bayou, lake, river, stream, or other public waters.

### R.S. 56:578.11(B) is all proposed new law.

B. No catfish or catfish product in this state shall be distributed, handled, held, manufactured, packaged, prepared, processed, sold, or offered for sale in this state unless the catfish or catfish product is specifically labeled in the following manner:

(1) "FARM-RAISED CATFISH, A PRODUCT OF LOUISIANA" for farm-raised catfish produced in this state or catfish products made from such farm-raised catfish, provided the appropriate state name or "USA" or "United States of America" may be substituted for "Louisiana" to accommodate farm-raised catfish or catfish products produced in any one of the other states of the United States of America.

(2) "WILD CATFISH, A PRODUCT OF LOUISIANA" for wild catfish, produced in this state or catfish products made from such wild catfish provided the appropriate state name or "USA" or "United States of America" may be substituted for "Louisiana" to accommodate wild catfish or catfish products produced in any one of the other states of the United States of America.

(3) "OCEAN CATFISH, A PRODUCT OF LOUISIANA", for ocean catfish, produced in this state waters or catfish products made from such ocean catfish provided the appropriate state name or "USA" or "United States of America" may be substituted for "Louisiana" to accommodate ocean catfish products produced in any one of the other states of the United States of America.

(4) "IMPORTED CATFISH, A PRODUCT OF" followed by the name of the country of origin for any catfish product that has a country of origin other than the United States of America.

R.S. 56:578.11(C) is all proposed new law.

C. All labeling shall be in English and in clear and conspicuous letters.

**R.S. 56:578.11(D) is all proposed new law.** D. Any advertising as to any catfish or catfish product shall state the origin of the catfish or catfish product, as provided in this Section. R.S. 56:578.11(E) is all proposed new law.

E. Any catfish and catfish product that are sold in a container, covering, package, or wrapping shall have the label required by Subsection B of this Section affixed to either the catfish or catfish product or to the immediate container, covering, package, or wrapping.

#### R.S. 56:578.11(F) is all proposed new law.

F. Any catfish or catfish product that is displayed for sale or sold unwrapped shall have a sign included with the display with the information required by Subsection B of this Section.

#### R.S. 56:578.11(G) is all proposed new law.

G. The information required by Subsection B of this Section shall be provided to each consumer prior to purchase for any catfish or catfish product that is sold or offered for sale, but which is not wrapped or displayed for sale.

#### <u>Ř.S. 56:578.11(H) is all proposed new law.</u>

H. (1) No person involved in the sale of catfish to consumers shall use the term "catfish" as a common name or as the name of any fish or fish product offered for sale to consumers except as provided in this Section.

(2) No person shall use the term "catfish" or "catfish product" when advertising, distributing, or labeling any fish or fish product that is not defined as "catfish" or "catfish product" in this Section.

(3) Any person failing to properly label any catfish product or failing to provide any notice required in this Section may be subject to the penalties provided in R.S. 56:34.

(4) Any person who intentionally misbrands or mislabels any catfish product or who fails to maintain the records required in this Section may be subject to the penalties provided in R.S. 56:36"
