(b) During any session convening in an odd-numbered year, no matter intended to have the effect of law, including any suspension of law, shall be introduced or considered unless its object is to enact the General Appropriation Bill; to enact the comprehensive capital budget; to make an appropriation; to levy or authorize a new tax; to increase an existing tax; to levy, authorize, increase, decrease, or repeal a fee; to dedicate revenue; to legislate with regard to tax exemptions, exclusions, deductions, reductions, repeals, or credits; or to legislate with regard to the issuance of bonds. However, a legislative instrument intended to have the effect of law, including a suspension of law, which is not within the subject matter restrictions provided in this Subparagraph may be considered at any such session if it is either prefiled as provided in Subparagraph (2) of this paragraph, provided that no member may prefile more than five such instruments; or if its object is to enact a local or special law which is required to be and has been advertised in accordance with Section 13 of this Article and which is not prohibited by the provisions of Section 12 of this Article.

Chapter 8-H is all proposed new law.

§844.11. Legislative findings

R.S. 45:844.11 is all proposed new law.

Because the legislature recognizes that becoming a residential telephone subscriber should not undermine or lessen a person's right of privacy, it finds that there is a compelling state interest to protect the privacy of such subscribers who wish to avoid unsolicited and unwanted telephone solicitations by enacting the "Telephone Solicitation Relief Act of 2001".

§844.12. Definitions

R.S. 45:844.12 is all proposed new law.

As used in this Chapter, the following terms and phrases shall have the meanings hereinafter ascribed to them:

- A. "Commission" means the Louisiana Public Service Commission.
- B. "Telephone solicitation" means any voice communication made by a telephone solicitor to a residential telephone subscriber for the purpose of encouraging a sale or rental of, or investment in property, consumer goods, or services; or for the purpose of encouraging an extension of credit for property, consumer goods, or services; or for the purpose of obtaining information that will or may be used for the direct solicitation of a sale or rental of, or investment in property, consumer goods, or services or an extension of credit for such purposes, or for the solicitation of a contribution to a charitable organization, but does not include telephone communications:
 - (1) In response to an express request of the person called.

- (2) Primarily in connection with an existing debt or contract, payment or performance of which has not been completed at the time of such call.
- (3) To any person with whom the telephone solicitor has an existing business relationship.
- (4) On behalf of an organization which has nonprofit status under Section 501(C)(3) or (6) of the Internal Revenue Code, unless such organization utilizes the services of a paid professional solicitor as defined in R.S. 51:1901(6).
- (5) For the purpose of conducting marketing research, public opinion polling, or similar activities that do not involve telephone solicitation or selling, or

- (6) Constituting political activity.

 C. "Telephone solicitor" means any natural person, firm, organization, partnership, association, or corporation, or a subsidiary or affiliate thereof, doing business in this state, who makes or causes to be made a telephone solicitation, including but not limited to calls made by use of automated dialing or recorded message devices.
- D. "Residential telephone subscriber" means any natural person who has subscribed to residential telephone service from a local exchange company, or any other natural person living or residing with
- E. "Doing business in this state" means conducting a telephone solicitation either from a location within this state, or from a location outside of this state to residential telephone subscribers residing in this

§844.13. Duties of the commission

- R.S. 45:844.13 is all proposed new law.

 A. The commission shall direct each local exchange company to establish and provide for the operation of a data base to compile a list of telephone numbers of residential telephone subscribers who object to receiving telephone solicitations. It shall be the duty of the commission to ensure that each local exchange company shall have such data base in operation no later than January 1, 2002.
- B. Each data base shall be regulated by the commission and maintained and operated by each local exchange company.
- C. No later than January 1, 2002, the commission shall promulgate
- (1) Require each local exchange company to notify its residential telephone subscribers of the opportunity to provide notification to the commission or its contractor that such subscriber objects to receiving telephone solicitations. The forms of notification shall include, but not be limited to, conspicuous monthly notices printed directly on the billing statements mailed to its residential telephone subscribers, and conspicuous publication of the notice in the consumer information pages of the local telephone directories.
- (2) Direct each local exchange company to establish a toll-free telephone number that each residential telephone subscriber may call to give it notice of his objection to receiving such telephone solicitations or revocation of such notice.
- (3) Specify the length of time for which a notice of objection shall be effective and the effect of a change of a telephone number on such
- (4) Specify the methods by which such objections and revocations shall be collected and added to the data base.
- (5) Specify the methods by which any person or entity desiring to make telephone solicitations will obtain access to the data base as required to avoid calling the telephone numbers of residential telephone subscribers included in the data base.
- (6) Specify such other matters relating to the data base that the commission deems desirable.
- D. If, pursuant to 47 U.S.C. Section 227(c)(3), the Federal Communications Commission establishes a single national data base of telephone numbers of subscribers who object to receiving telephone solicitations, the commission shall include the part of such single national data base that relates to Louisiana in the data base established under this Chapter.

§844.14. Listing procedures; prohibited acts

R.S. 45:844.14 is all proposed new law.

A.(1)(a) Any residential telephone subscriber desiring to be placed on a "do not call" list shall be placed on that listing upon notification to

the subscriber's local exchange company. This listing shall be renewed by the commission annually for each subscriber, unless the local exchange company receives written notice from the subscriber to remove him from the "do not call" list.

(b) Any residential telephone subscriber whose number is private shall automatically be placed on his local exchange company's "do not call" list, unless the subscriber gives written notification to the local exchange company to remove his number from the "do not call" list.

(2) The local exchange companies shall update its "do not call" list quarterly. The list shall include the telephone numbers, but not the names or addresses, of residential telephone subscribers, arranged by area code and numerical sequence, who do not want to receive telephone solicitations, as defined in this Chapter.

- (3)(a) Telephone solicitors, as defined in this Chapter, doing business in this state shall obtain copies of the "do not call" listing by paying a fee to the local exchange companies in an amount not to exceed the costs incurred by the local exchange company in the presentation, production, and distribution of that listing. The local exchange company shall offer a statewide listing and shall also offer listings of areas within the state of their subscribers. The determination of the number and definition of areas shall be within the discretion of the local exchange companies.
- (b) In order to obtain copies of the "do not call" listing, a telephone solicitor shall, in addition to paying the applicable fees to the local exchange company, register with the commission and provide all necessary documentation as required by the local exchange company. Such telephone solicitor, as defined in this Chapter, shall also be required to maintain a bond in the amount of fifty thousand dollars as provided in R.S. 45:829(A) and file a copy of such bond with the
- (4) All fees and penalties imposed pursuant to this Section, other than those provided in paragraph 3(a) of this Section, shall be made payable to the Louisiana Public Service Commission for the administration of this Chapter.
- B. No person or entity that sells, leases, or rents telephone solicitation listings, except for directory assistance and telephone directories sold or distributed by local exchange companies or their affiliates, shall include in such listings any residential telephone number if the number for that telephone appears on the commission's then current "do not call" listing.

§844.15. Violations; penalties

R.S. 45:844.15 is all proposed new law.

The commission shall investigate any complaints received concerning violations of this Chapter. If, after investigating such complaint, the commission finds that there has been a violation of this Chapter, then the commission shall impose an administrative penalty against the telephone solicitor not to exceed one thousand five hundred dollars for each violation. If the violation is committed against a residential telephone subscriber over the age of sixty-five, then the commission shall impose a penalty not to exceed three thousand dollars for each violation.

Section 3. This Act shall become effective upon signature by the governor or, if not signed by the governor, upon expiration of the time for bills to become law without signature of the governor, as provided in Article III, Section 18 of the Constitution of Louisiana. If vetoed by the governor and subsequently approved by the legislature, this Act shall become effective on the day following such approval."
